INSTRUCTIONS FOR FILLING OUT THIS FORM

Somehow lists of FIVE COPIES EACH, will be filled out by each company or detachment commander as follows:

1st List: Officers arranged according to rank, senior, if any, within each grade, if any. These names should be numbered consecutively beginning with No. 1.

2d List: Non-commissioned officers above Grade 10, (Paragraph 9, Army Regulations), arranged according to grade.

3d List: Enlisted men below Grade 10, (Paragraph 9, Army Regulations), arranged according to the usual formation of the Company, that is, by squads. These names should be numbered consecutively beginning with No. 1.

To be filled in by Organization: Give full name of organization including company and regimental designation. COMPANY "L" 132ND INFANTRY U.S.A.G.
