 - (1) "Retired," (2) "Discharged," (3) "Resigned," (4) "On Leave," (5) "For Discharge," (6) "For Duty," (7) "For Retirement," (8) "For Orders," (9) "Discharged."
3. Each group will be arranged according to rank and grade (see A. R., Part 5, Army Field Orders and Field Circulars).
4. U. S. C. is to be included between officers and enlisted men.
5. The names will be numbered consecutively within each group, beginning with No. 1.
